## CALL TO ORDER

1. Approval of the agenda notice with addition of any emergency item and/or deletion of any item.

2. Pledge of Allegiance.

The Board of Eureka County Commissioners met pursuant to law on November 18, 2025. Present were Chairman Rich McKay, Vice Chair Marty Plaskett, Commissioner Mike Schoenwald, District Attorney Ted Beutel and Clerk Recorder Kathy Bowling. The meeting was called to order at 9:31 a.m. The interactive video conferencing system was connected between Crescent Valley and Eureka for the entire meeting.

Commissioner Plaskett motioned to approve the agenda, Commissioner Schoenwald seconded the motion. The motion carried 3-0.

The meeting began with the pledge of allegiance.

Chairman McKay called for public comment in both Eureka and Crescent Valley, hearing none he proceeded to the next item.

## **COUNTY COMPTROLLER** – Kim Todd, Comptroller

1. Payment of expenditures. *Notice: Expenditures received after action has been taken under this Comptroller section may be presented and acted upon throughout the day. (For Possible Action)*

The board along with Comptroller Kim Todd reviewed expenditures.

Commissioner Plaskett motioned to approve the expenditures in the amount of \$2,086,652.02 with passthroughs of \$683.40 to Nevada Department Taxation room tax, \$1,101,679.07 to Nevada State Controller school taxes, \$9,211.75 to Nevada State Controller, \$53,620 to Nevada Division of Minerals, \$168 to Washoe County Crime Lab for a total of \$1,165,362.21.

2. Review Fund Balance Report. **(Discussion)**

The board reviewed the current fund balance report.

## **COMMISSIONERS**

1. Discuss, approve or deny accepting the single appraisal report from Janelle Wright, Certified Public Appraiser, for a portion of APN 001-221-14, and set a lease value for that portion of the property designated as the site for construction of the Boys & Girls Club facility. **(For Possible Action)**

Commissioner Plaskett motioned to approve accepting the single appraisal report from Janelle Wright, Certified Public Appraiser, for a portion of APN 001-221-14, and set a lease value of \$1 a year for the portion of the property designated as the site for construction of the Boys & Girls Club facility. Commissioner Schoenwald seconded the motion. The motion carried 3-0.

2. Discuss, approve or deny making changes to the County Room Tax ordinance, specifically Title 4 Licenses, Permits, Fees and Taxes, Chapter 50, .010 Definitions, G.; and if in favor schedule a public hearing for a future meeting. **(For Possible Action)**

Chairman McKay who also sits on the Recreation Board explained that currently the County Room Tax ordinance has an exemption that if a business had 3 rooms or less they don't have to pay room tax. The Recreation Board would like to change it to read 1 room or less, so those that have less than 3 rooms like Air BnB's and RV hookups will have to pay the room tax. The County Room Tax is 8% and doesn't apply once a person has stayed longer than 28 days. Recreation Board secretary Robin Hicks commented there is currently 1 RV park in Eureka paying the room tax and 1 in Crescent Valley, changing the ordinance would put the responsibility on more businesses.

Commissioner Plaskett motioned to approve making changes to the County Room Tax ordinance, specifically Title 4 Licenses, Permits, Fees and Taxes, Chapter 50, .010 Definitions, G. and setting the public hearing for 10 am on December 16<sup>th</sup>. Commissioner Schoenwald seconded the motion. The motion carried 3-0.

**CRESCENT VALLEY VOLUNTEER FIRE DEPARTMENT** – Jeremy Rice

1. Discuss, approve or deny a donation of \$500.00 from the North End Activity Fund to purchase gift cards as prizes for the Parade of Lights event scheduled in Crescent Valley on December 13, 2025 and if approved, issue the check to Jeremy Rice. **(For Possible Action)**

Commissioner Plaskett motioned to approve a donation of \$500.00 from the North End Activity Fund to purchase gift cards as prizes for the Parade of Lights event scheduled in Crescent Valley on December 13, 2025 and to issue the check to Jeremy Rice. Commissioner Schoenwald seconded the motion. The motion carried 3-0.

**Chairman McKay recessed the regular meeting to open the public hearing.**

**PUBLIC HEARING – 4/10 WORK WEEK**

*Notice was given that the Board of Eureka County Commissioners will hold a public hearing on November 18, 2025, beginning at 10:00 a.m. in the Eureka County Commission Chambers in the County Courthouse at 10 South Main Street, Eureka, Nevada. The reason for said hearing is to invite public comments and consider adopting and implementing a 4-10 work week schedule for some if not all County Offices.*

1. Presentation by the committee appointed to provide 4-10 work week data to the Board of County Commissioners. **(Discussion)**

The 4-10 committee made up by Human Resource Director Cristina Lopez, Assessor Michael Mears, Clerk Recorder Kathy Bowling and CIO Misty Rowley presented to the board data collected supporting a 4-10 work week. The PR firm Market Share sent out a survey to 72 employees, department heads and elected officials, they had 60 return showing a strong support of the 4-10 work week. Assessor Mears summarized the results of the survey, 82.5% were in favor of the 4-10 work week, 53% of the employees stated they would consider moving to a position if it offered a 4-10 schedule. The employees who already work a 4-10 stated they have found zero challenges operating under a 4-10 schedule. The survey also indicated that recruitment and retention would significantly improve under a 4-10 schedule. They discussed the lunch hour would change to a half hour lunch open from 12:30 to 1 lunch hour to be open for the employees at the school district. Both the DMV and eRecording in the Clerk Recorders office have to close half an hour early, being open until 5:30 will give mine workers more availability during shift change. Assessor Mears also mentions the DMV is going completely online and the state is potentially closing satellite offices, which would include Eureka. Clerk Recorder Kathy Bowling mentioned that her office tracked foot traffic for 9 months, and over 37 Fridays 20 of those saw 0 in person

visitors, 4 of those Fridays saw in person visitors recording mining claims. Jeb Rowley commented that his office also tracked Friday foot traffic and showed a significant decline in normal volume.

2. Open public hearing and invite comments on the implementation of a 4-10 work week schedule, or possible pilot program of 12 to 18 months, for some if not all County Offices. **(Discussion)**

Chairman McKay opened the public hearing for comments, Appraiser Supervisor Matthew Crimm echoed Assessor Mears sentiments and also commented on the travel that his office sees to the North end of the County and how the extra 2 hours would greatly benefit their work day. Patricia Aiken commented in support of the 4-10 work week and commented on the better retention of employees and how it can create a better work environment. Kathy Porter commented the 4-day week is one of the reasons she moved from a county office to the school district years ago. She also commented on the great benefit the 4-10 office schedule would be to staff and their families. Eureka County was the first school district to switch to the 4-day school week over 17 years ago and since then 13 of Nevada's 17 school districts have made the switch. Kathy Porter also commented that she personally does not come to town on Fridays to conduct business she chooses to do it during the week. Laura Shivers commented on her concern of availability to mine workers, retail and restaurant workers, she commented on the option of a survey the public could take. Robin Hicks commented that she worked for the school district when it was transitioning to the 4-day school week, the admin worked a rotating 4-10 schedule covering Fridays. She commented that if they needed to be open on Fridays for the public, offices could consider rotating the Friday option. Winnona Eversgerd commented she retired from the school district and was part of the group who really pushed to do the 4-day week at the school. She commented in favor of the pilot study. She commented that at the time the main complaint was childcare on Fridays and those worries mainly came from those who worked for the county. She believes the core of our community is looking out for our families. Winnona Eversgerd also commented that she owns a business on main street and Friday is their slowest day of the week to the point they aren't even open. Public Works Director Jeb Rowley commented in support of the 4-10, he commented he can not justify staying open on Fridays for the potential of a credit card payment over the phone. Sheriff Umina commented in support, he mentioned that his patrol staff work a rotating schedule, and he sees the benefit of having more days off in a row. He has seen happier and more productive staff in his office. Comptroller Kim Todd commented the Board may see departments requesting more employees to help cover the extra hours during the day, she commented that her office can not do the 5-10 schedule rotating Fridays due to not having enough employees. She commented she does not think we owe it to the taxpayers to add more employees just to accommodate a schedule. Deputy Clerk Recorder Katelyn Ziemann commented that the public can access documents 24/7 through the county website and print them for free. They also already offer eRecording, people can submit documents 24/7 as well. She believes that being open half an hour longer in the evening would help accommodate those who are changing shifts. Senior Center Director Linda Gordon commented she would like to see the 2 senior centers on the same schedule but still being open for food bank and Friday breakfast.

**Chairman McKay closed the public hearing.**

3. Discuss, and consider implementing a 4-10 work week schedule, or a pilot program of 12 to 18 months and if approved, decide date by which it will be implemented and how to notice the public and employees. **(For Possible Action)**

The board along with department heads discussed the length of the pilot program and which offices it would affect. The offices that the NRS 245.040 states may deviate from the hours of operation are Eureka County Sheriff, Assessor, Clerk-Recorder, Treasurer and Comptroller (Auditor), District Attorney and Justice Court. The board agreed that all other departments may choose the 4-10 or 5-8 schedule that best fits their employees. Starting January 4, 2026 to line up with payroll, the County offices will move to a 4-10 work week for a pilot period of 12 months. The Board talked about notices in the paper, posting them on websites, newspapers and throughout town to get the word out to the public.

Commissioner Schoenwald motioned to approve implementing a 4-10 work week schedule for a pilot program of 12 months starting January 4, 2026. Commissioner Plaskett seconded the motion. The motion carried 3-0.

**The Board took a 10-minute break.**

**Chairman McKay called the meeting back to order at 11:16 am.**

**SENIOR CENTERS** - Linda Gordon, Senior Center Program Director

1. Report on activities at the Eureka Senior Center and Fannie Komp Senior Center. **(Discussion)**

Senior Center Program Director Linda Gordon reported for October she collected \$3,570, Crescent Valley served 717 meals and Eureka served 905 meals. The Pan Mine ordered lunch for their workers a few times, adding non senior meals to Eureka's count. Director Gordon reported the freezers have all been fixed and they are keeping all the food in the Senior Center again. The Eureka Senior Center is scheduled to be painted around the first of December. Director Gordon updated the Board on the NDOT grant for the wheelchair vans, the money will not go back to the County it will now go to an operating fund to pay for oil changes and tires. The amount is for \$140,193, they would have to spend over \$6,000 a month on the vans. Director Gordon does not believe they use the vans enough to justify \$6,000 a month when the vans are used a handful of times a month. Director Gordon would like to deny the grant and the county continue to cover the operating expenses themselves. She will bring a letter before the board in a future meeting to be approved.

**CRESCENT VALLEY TOWN ADVISORY BOARD-**

1. Discuss, approve or deny utilizing funds from Capital Outlay budgeted in the Crescent Valley Town Budget, in an amount not to exceed \$30,000.00, for the purchase of fitness equipment to be installed at the Crescent Valley Town Park. **(For Possible Action)**



The Crescent Valley Town Advisory Board budgeted for new fitness equipment to be installed in the Crescent Valley town park. Comptroller Kim Todd corrected that the equipment would come out of the Eureka General Fund Parks budget.

Commissioner Schoenwald motioned to approve utilizing funds from the Eureka General Fund Parks budget in an amount not to exceed \$30,000.00, for the purchase of fitness equipment to be installed at the Crescent Valley Town Park. Commissioner Plaskett seconded the motion. The motion carried 3-0.

**IT**-Misty Rowley, CIO

1. Discuss, approve or deny Order #Q-427568 from PowerDMS by NeoGov for an annual recurring Single Sign-On subscription for the term of December 1, 2025 through November 30, 2026, in the amount of \$1,276.00, and a one-time setup fee of \$3,150.00. **(For Possible Action)**

CIO Misty Rowley explained the PowerDMS by NeoGov is software the Sheriff's office and Human Resources use for background investigations.

Commissioner Plaskett motioned to approve the quote #Q-427568 from PowerDMS by NeoGov for an annual recurring Single Sign-On subscription for the term of December 1, 2025 through November 30, 2026, in the amount of \$1,276.00, and a one-time setup fee of \$3,150.00. Commissioner Schoenwald seconded the motion. The motion carried 3-0.

2. Discuss, approve or deny approving the Third-Party Authorization Form for Redbud Telecom Consulting, allowing them to file all FCC forms required to seek federal Rural Health Care Program funding to connect the Crescent Valley Clinic via fiber for the purpose of increased broadband internet at a reduced rate. **(For Possible Action)**

Redbud Telecom Consulting is the company that helps the County get funding for the fiber at the Crescent Valley clinic. Approving the Third-Party Authorization form will help to increase the broadband internet at a reduced rate.

Commissioner Plaskett motioned to approve the Third-Party Authorization Form for Redbud Telecom Consulting, allowing them to file all FCC forms required to seek federal Rural Health Care Program. Commissioner Schoenwald seconded the motion. The motion carried 3-0.

3. Discuss, approve, or deny authorizing Quote #021615v1 from Quest to replace the camera server at the Eureka Pool and Airport for a not to exceed amount of \$11,804.71 utilizing funds budgeted for capital outlay (010-018-55010-000) in the Technology Support budget. **(For Possible Action)**

Both the camera servers at the Eureka Airport and Pool are reaching their end of life, quote #021615v1 from Quest for an amount of \$11,804.71 will be to replace both camera servers.

Commissioner Plaskett motioned to approve Quote #021615v1 from Quest to replace the camera server at the Eureka Pool and Airport for a not to exceed amount of \$11,804.71 utilizing funds budgeted for capital outlay (010-018-55010-000) in the Technology Support budget. Commissioner Schoenwald seconded the motion. The motion carried 3-0.

4. Discuss, approve, or deny authorizing Quote #021618v1 from Quest to replace the camera server in Crescent Valley for a not to exceed amount of \$20,545.18 utilizing funds budgeted for capital outlay (010-018-55010-000) in the Technology Support budget. **(For Possible Action)**

CIO Rowley explained the camera server in Crescent Valley reached its end of life and since they are increasing the resources in Crescent Valley, they are going to install a bigger system.

Commissioner Plaskett motioned to approve Quote #021618v1 from Quest to replace the camera server in Crescent Valley for a not to exceed amount of \$20,545.18 utilizing funds budgeted for capital outlay (010-018-55010-000) in the Technology Support budget. Commissioner Schoenwald seconded the motion. The motion carried 3-0.

**DISTRICT ATTORNEY**- Ted Beutel, DA or Holli Else, Assistant DA

1. Discuss, approve, or deny authorizing the District Attorney's Office to spend an amount not to exceed \$10,000.00 for the integration of Sunridge RIMS software interface with Prosecutor by Karpel software. **(For Possible Action)**

District Attorney Beutel explained that currently the recording software used by law enforcement and by the prosecutor's office are not communicating with each other. Integrating Sunridge RIMS with Prosecutor by Karpel software would change reports from being physically handled too electronically.

Commissioner Plaskett motioned to approve authorizing the District Attorney's Office to spend an amount not to exceed \$10,000.00 for the integration of Sunridge RIMS software interface with Prosecutor by Karpel software. Commissioner Schoenwald seconded the motion. The motion carried 3-0.

2. Discuss, approve or deny out-of-state travel for Holli Else, Esq. and Heather Anderson to attend the Prosecutor by Karpel training conference in St. Louis, Missouri, scheduled April 13th-16th (April 13th will be a travel day). **(For Possible Action)**

Commissioner Plaskett motioned to approve out-of-state travel for Holli Else, Esq. and Heather Anderson to attend the Prosecutor by Karpel training conference in St. Louis, Missouri, scheduled April 13<sup>th</sup> -16<sup>th</sup>. Commissioner Schoenwald seconded the motion. The motion carried 3-0.

3. Discuss, approve or deny one-time credit card increases of \$500.00 (total \$1,000.00) for both Holli Else, Esq., and Heather Anderson for the months of December 2025, January 2026, and April 2026. These increases are for the registration for the Prosecutor by Karpel conference (December 2025); airline tickets for the conference (January 2026); and hotel rooms for the conference (April 2026). **(For Possible Action)**

Increasing both Holli Else and Heather Anderson's credit card limits for December and January will help them to register for the conference, purchase airfare, and hotel purchases in April.

Commissioner Plaskett motioned to approve a one-time credit card increase of \$500.00 (total \$1,000.00) for both Holli Else, Esq., and Heather Anderson for the months of December 2025, January 2026, and April 2026. Commissioner Schoenwald seconded the motion. The motion carried 3-0.

#### **AMBULANCE AND EMS** – Nichole Cooley, EMS Director/Coordinator

1. Report on EMS projects and activities. **(Discussion)**

EMS Director Nichole Cooley, EMT Griffin Bussian and EMT Brent Jones attended the HAZMAT awareness class with LEPC and received their certificates. They have 4 high school students signed up for the Aspire program, they are working on getting them CPR certified and setting up hospital tours in both Elko and Ely. Director Cooley has also been working with Sheriff Umina to do ride alongs with the Aspire students. They will be receiving a LifePack 15 trial monitor to test until the end of December, Director Cooley will continue to keep the board updated on the status of the monitors moving forward.

2. Report on contract services. **(Discussion)**

Director Cooley reported the total runs for October in Eureka were 24, Eureka MedEx had 3, Crescent Valley had 7 and Crescent Valley MedEx had 1. For the month of October EMS brought in \$8,312.50. The dentist in Eureka saw 37 patients, Genesis has 5 nursing patients and PCA had a total of 18 patients. The Eureka clinic saw 325 patients, Tamisha saw 186 and Laurel saw 124, Harper saw 3 and Perkins saw 1 and other was 11. The Crescent Valley clinic saw 20 patients.



## **SHERIFF- Miles Umina, Sheriff**

### **1. Report on Sheriff's Office projects and activities. (Discussion)**

Sheriff Umina and Undersheriff Cobb reported Dalton Kemp graduated from POST and is now a CAT 1 peace officer, he will be shadowing other deputies for a trial period before he joins patrol. The Sheriff's office has 1 in custody in White Pine County and 1 in NDOC. For the month of November, they have made 52 traffic stops and issued 22 citations. Sheriff Umina reported on the burglary rumors on Facebook, the Sheriff's office has not received any reports on residential burglaries. Sheriff Umina commented that the Sheriff's office can not do anything to help if nothing is reported, he encouraged people to call the Sheriff's office and report any suspicious activity.

## **PUBLIC WORKS/COUNTY FACILITIES – Jeb Rowley, Public Works Director**

### **1. Update on Public Works projects and activities, including activities and events at County-managed facilities. (Discussion)**

Public Works Director Jeb Rowley reported the Opera House had 202 total attendees and 109 visitors for tours; the museum had 102 total visitors. The swimming pool had 104 daily swimmers, pool supervisor Crystal Rikalo has completed all the certifications needed. The Crescent Valley Community Center had 150 people attend their Christmas bazaar. October was free dump days, and the Eureka landfill had a total of 524 deliveries and the Crescent Valley transfer site had 108 yards of waste.

### **2. Discuss, approve or deny authorizing change order for PWP -EU-2025-272, Test Borehole Drilling for Groundwater Exploration, Kobeh Valley Well and Transmission Main Project, and authorize Director Jeb Rowley to so sign the change order outside the meeting. (For Possible Action)**

Director Rowley explained the change order for PWP -EU-2025-272, Test Borehole Drilling for Groundwater Exploration, Kobeh Valley Well and Transmission Main Project will change the amount from \$323,925 to \$334,800. As they continue with the project, they need to increase the conductor size resulting in the amount changing.

Commissioner Plaskett motioned to approve the change order of \$334,800 for PWP -EU-2025-272, Test Borehole Drilling for Groundwater Exploration, Kobeh Valley Well and Transmission Main Project, and authorize Director Jeb Rowley to sign outside the meeting. Commissioner Schoenwald seconded the motion. The motion carried 3-0.

**1. Report on current and emerging natural resource issues affecting Eureka County. (Discussion)**

Natural Resources Manager Jake Tibbitts reported that while he was in Washington DC for the CARROT Executive Committee, he had the opportunity to meet with the American Seed Trade Association, the Farm Journal Foundation, Kraft Heinz, and the Farm Bureau. They discussed furthering the partnership with the ag advocacy and literacy. The Conservation District had their 75<sup>th</sup> Anniversary dinner and had about 90 people attend and raised \$1,300 for their youth scholarship. Manager Tibbitts will attend a water rights retirement working group meeting. The 2 bills passed in the last legislative session SB36 and AB104 created the framework for the groundwater right retirement throughout the state, the working group will meet regarding those bills. I-80 Gold will host a town hall meeting at the Opera House on the 19<sup>th</sup> at 6:30. November 20<sup>th</sup> the town of Eureka Community Development Strategy hosted by the UNR and College of Business will hold a workshop at the Annex from 9 to 4. NV Energy reached out and would like to attend the December 16<sup>th</sup> BOCC meeting and provide updates on the Greenlink North Project.

**2. Discuss and consider accepting invitation to be a cooperating agency in the South Railroad Mine Project pursuant to Title 41 of the Fixing America's Surface Transportation Act (FAST-41). (For Possible Action)**

Under the National Environment Policy Act Congress recently passed, fast act fixing Americas Surface Transportation Act and allows certain projects that fall within that overall policy of the administration. The South Railroad project has received that designation. Eureka County has been a cooperating agency under NEPA, accepting the invitation would additionally streamline the process.

Commissioner Schoenwald motioned to approve accepting the invitation to be a cooperating agency in the South Railroad Mine Project pursuant to Title 41 of the Fixing America's Surface Transportation Act (FAST-41). Commissioner Plaskett seconded the motion. The motion carried 3-0.

**3. Discuss and consider response to US Department of Agriculture Plan to Fortify the American Beef Industry: Strengthening Ranches, Rebuilding Capacity, and Lowering Costs for Consumers. (For Possible Action)**

Following recent decisions regarding Tariffs on imported beef the US Department of Agriculture created a plan to fortify the American beef industry strengthening ranches, rebuilding capacity and lowering costs for consumers. The suggested letter will go to NRAC for their approval, pushing support for advocating grazing and allotments, support giving ranchers a voice and bolstering the meat processing plants. Fred Buckmaster made a public comment on the Forest Service and their

permitting; he would like to see neighbor partnerships promoted and grazing allotments used for fire control and to help the overall cattle numbers.

Chairman McKay motioned to approve a response to US Department of Agriculture Plan to Fortify the American Beef Industry and allow NRAC to add to the comments. Commissioner Plaskett seconded the motion. The motion carried 3-0.

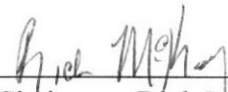
